Thank you for wanting to contribute to my campaign for City Council. I am very excited to be running and appreciate your support.

There are 2 ways to contribute to my campaign for City Council.

- 1). online at DoriaSumma.com/donate which accepts both credit card and check donations or
- 2). by check with the completed *Required Information form* on the next page. If contributing online, you will be prompted for the same information.

California law REQUIRES campaigns to collect and report certain donor information. Penalties can be imposed for vague or incomplete information. Negative press can also be generated if any of the required information is missing. We must have this information and will need to contact you if your contribution form is incomplete.

This REQUIRED information becomes part of the public record. Cumulative contributions under \$50 are not reported and do not become part of the public record. The cumulative limit per contributor is \$4,900.00.

Guidance from state government on Occupation and Employer:

- If not employed – "retired", a "student", a "homemaker" etc. – enter "**None**" for employer.
- If "self-employed" or an "independent consultant" and have no company name, enter "**No Separate Business Name**".
- If employed, please list your **company's official name**. Examples:
 - "Stanford" is an incomplete name for Stanford University.
 - NO Acronyms: "UPS" is an acronym, not the company's official name. However, many companies have used their former acronyms in renaming themselves.
- Occupation: The State provides only [a few examples of what is needed](https://bit.ly/3KrUjGU) (<https://bit.ly/3KrUjGU>):
 - **Too vague:** "Investor"; **Adequate** "Private Investor, stocks & bonds"
 - **Too vague:** "Entrepreneur", "Business Person", "Manager"
